

## **TERMS OF USE**

**Please read these Terms of Use (“Terms of Use”) carefully before using this web site <http://www.math4mobile.com/> (“the Web Site”).**

The Math4Mobile mathematical applications on the Web Site were developed by Professor Michal Yerushalmy and Mr. Arik Weizman at the University of Haifa, Israel (“**Haifa University**”) as a tool for teaching and learning mathematics using a mobile phone (“**Math4Mobile**”). All proprietary and intellectual property rights in and to Math4Mobile and the information related thereto appearing on the Web Site, are owned by **Carmel-Haifa University Economic Corporation Ltd. (“Carmel”)**, the commercial arm and technology transfer office of Haifa University.

These Terms of Use set out the entire terms and conditions for using Math4Mobile and the Web Site. By entering and/or using the Web Site and/or downloading and/or using Math4Mobile, you agree to abide by these Terms of Use. If you do not agree to be bound by and comply with all of the foregoing, you may not access or use the Web Site and/or download or use the Math4Mobile applications and/or related information available on the Web Site.

You are only entitled to use this Web Site and/or download and/or use Math4Mobile for non-commercial purposes.
